
REQUEST FOR EXPRESSION OF INTEREST

Request for Expression of Interest is invited by Mehran University of Engineering and Technology, sub-campus Jacobabad from already pre-qualified consultants in Region-I, Category-I from Higher Education Commission, Pakistan for preparation of Master Plan for Civil, Electrical, Plumbing, Sewerage / Drainage, Water Supply, Landscape & External Development, IT & Communication, Roads, Furnitures & Fixtures, HVAC, Firefighting Systems etc. works defined in the scope of the development scheme for Sub Campus of Mehran University of Engineering and Technology at Jacobabad.

1. The Consultants shall be required to submit a bid comprises of a single package containing two (02) separate envelopes. Each envelope shall contain separately the ‘Financial Proposal’ and the ‘Technical Proposal’.
2. The Financial Proposals shall be opened of those Consultants whose technical proposal is considered and approved.
3. The Selection of Consultants shall be made as per Evaluation Criteria method as mentioned in the document of Request for Proposal.
4. The Consultants shall be required to provide also following documents at the time of Bid submission
 - (a) Certificate of registration of a Firm with Pakistan Engineering Council or registration with professional body of country of origin for foreign firm.
 - (b) Documents to substantiate the forming of JV/Association as per guidelines of the governing body (PEC/PCATP) if any.
 - (c) National Tax Number of consultant(s).
 - (d) Audited Statements of Accounts and Annual Turnover for the last three years.
 - (e) Details of maximum of **10** similar assignments (developmental works of HEI’s) worth amount specified Category - I (i.e. more than Rs. 500 million).
 - (f) A certificate / affidavit that the firm has not been blacklisted or debarred by any Government / Autonomous / International Body.
5. Interesting Consultants may obtain the Request For Proposal (RFP) document on the payment of document fee amounting to Rs. 5,000.00 in shape of Demand Draft / Pay Order (Non-refundable) before the last date of submission of Expression of Interest, which has been fixed as **20-07-2018**. The incomplete Expressions or received after due date i.e. **20-07-2018** will not be considered.

Documents can be had from the office of the Deputy Director (Procurement), Mehran University of Engineering & Technology, Jamshoro, personally or by mail on any working day except the day of submission of applications or can be downloaded from SPPRA website i.e. www.pprasinhd.gov.pk on the required payment from **19-06-2018 to 19-07-2018** and will be submitted **One (01) Original and Three (03) copies of its EOI/application on 20-07-2018 upto 11.30 (Noon)** and same will be opened on **the same day @ 12.00 Noon** in the office of the Deputy Director (Procurement) in presence of the Consultants / representatives, who so ever will be present at that time
