MINUTES OF THE MEETING OF COMPLAINT REDRESSAL COMMITTEE (CRC) INORDER TO REDRESS THE GRIEVANCE / COMPLAINT OF M/S FAIZ SCIENTIFIC COMPANY, KARACHI ON THE TENDER INVITED FOR "PROCUREMENT OF DESKTOP COMPUTERS, MULTIMEDIA PROJECTORS & PRINTERS FOR MUET SZAB CAMPUS AT KHAIRPUR MIR'S" AS PER RULE – 31, OF SPPRA RULES, 2010 (AMENDED 2019) HELD ON TUESDAY, THE 3<sup>RD</sup> SEPTEMBER, 2019 AT 11:00 A.M. IN THE OFFICE OF THE DIRECTOR (WORKS & STRATEGIC PLANNING), MUET, JAMSHORO.

The Meeting of Complaint Redressal Committee (CRC) inorder to redress the grievance / complaint of M/s Faiz Scientific Company, Karachi on the tender invited for "Procurement of Desktop Computers, Multimedia Projectors & Printers for MUET SZAB Campus at Khairpur Mir's" as per Rule – 31, of SPPRA Rules, 2010 (Amended 2019), held on **Tuesday, the 3<sup>rd</sup> September, 2019 at 11:00 a.m.** in the office of the Director (Works & Strategic Planning), MUET, Jamshoro., and the following attended the meeting:

Complainant

The meeting was started with name of Allah Almighty. The Director (Works & Strategic Planning) welcomed all the members of committee for attending meeting and narrated the purpose of holding meeting. He informed that M/s Faiz Scientific Company, Karachi have lodged complaint / grievance on the on the tender invited for "Procurement of Desktop Computers, Multimedia Projectors & Printers for MUET SZAB Campus at Khairpur Mir's", therefore, inorder to redress their grievance this meeting is convened as per Rule – 31, of SPPRA Rule 2010 (Amended 2019), Govt. of Sindh.

Later on the representative of M/s Faiz Scientific Company, Karachi was called in the meeting before the Complaint Redressal Committee (CRC) and was asked to express his grievance. The detailed discussions were held regarding the matter among the members and representative of the firm. Also, during the meeting the representative of the firm became aggressive. He also threatened the CRC during discussion that if they were not awarded the work then they will drag all in the court of law, which is tantamount to blackmailing and creating hindrances in Govt. works.

As such, convening Complaint Redressal Committee meeting is the prior activity, but unfortunately due to following circumstances convened by the procuring agency after award of contract.

One member of CRC namely Mr. Ali Gohar Abro, Superintending Engineer, Education Works
Department, Circle Hyderabad regretted to attend meeting, therefore, the CRC was re-notified.
Copy of Notification is attached at Flag - 'A'.

- The representative of M/s Faiz Scientific Company, Karachi approach the members of CRC individually, expressed aggressiveness and demanded for favour.
- Due to acute demand of desktop computers by the various departments of SZAB Campus inorder
  to fulfill PEC accreditation needs of departments, procuring agency had not sufficient time to
  wait for CRC meeting therefore, they awarded the contract inorder to utilize funds as per
  instructions by the funds providing organizations i.e HEC & Govt. of Sindh.

Since, Bid Evaluation Report of the said tender was uploaded on authority website on 23-07-2019 and M/s Faiz Scientific Company, Karachi lodged their complaint on 25-07-2019. Afterwards, justification for not awarding work to complainant was conveyed by the procuring agency vide letter on 29-07-2019. Lateron, the contract was awarded to successful vender on 01-08-2019, who was best evaluated bidder.

After thorough inspection of case by the committee, it was found that the complainant i.e. M/s Faiz Scientific Company, Karachi has quoted the brand as per specs mentioned in the bid document, whereas, the successful bidder M/s Imran Electronics, Karachi quoted brand having advanced technology and their quoted brand is well known internationally acceptable commercial standards, therefore, the contract was awarded to them being the best evaluated bid which is in compliance with SPPRA Rule – 49: Award of Contract which clearly states that: "The bidder with the lowest evaluated cost, but not necessarily the lowest submitted price, shall be awarded the procurement contract, within the original or extended period of bid validity". However, still LC has not been opened due to delay in bank procedures.

## Decision:

Since, looking to the facts mentioned above contract was awarded but the LC could not opened and inorder to redress the complaint and make healthy competition among the venders, the contract as well as whole tender be cancelled and re-invited with proper technical specifications of Desktop Computers as per SPPRA Rules, 2010 (Amended 2019), Govt. of Sindh.
